ORDER

1. Principal, L.B.S. Institute of Technology for Women, Poojappura, Thiruvananthapuram, for short, the college, has submitted the draft prospectus to fill up 5% NRI quota seats in respect of B.Tech Course for the Engineering College for the academic year 2024-25 before the Admission Supervisory Committee, for short the Committee, for approval.

- 2. Having regard to the fact that approval/continuous affiliation from the AICTE has been received and having also regard to the statement of the college that proceedings for the issue of continuation affiliation by the KTU are being expedited, the prospectus can be provisionally approved subject to the condition that the Principal of the college shall produce the affiliation order from the KTU, at the earliest, in any event, within one month from the date of this order.
- 3. The draft prospectus is provisionally approved subject to observations and directions as stated below:
 - a. Applications invited by the College shall only be through online. No other mode of inviting application will be entertained.
 - b. College is not entitled to retain the first year tuition and other fees, if the student discontinues the course before the last date of admission prescribed by the competent authorities.
 - c. Principal of the College is directed to collect the tuition fee and special fee only through online payment/cheque/ DD/ RTGS/IMPS etc.

- d. College has no right to retain the certificates and TC in the case of students leaving the college midway. Certificates shall be released to the student after getting due acknowledgement.
- e. The College has included in the prospectus the tentative schedule for admission. Tentative schedule provided in the prospectus is modified with the following changes in the dates:
